Cookie Policy

According to regulatory requirements, we need your consent to set cookies when you first visit this website. You can also withdraw your consent at any time afterwards.

Use of the Cookie Management Platform OneTrust

This website uses the OneTrust cookie management tool to obtain effective user consent for cookies and similar technologies that require consent (hereinafter "cookies"). OneTrust is operated by OneTrust LLC, Dixon House, 1 Lloyd's Avenue, London, EC3N 3DQ, +44 (800) 011-9778 ("OneTrust").

By embedding a JavaScript code, a banner is displayed to users when they access the site, allowing them to give or refuse consent for the setting of cookies for individual purposes or functions of our website. In this process, the tool blocks the setting of all cookies requiring consent until the respective user grants such necessary consents.

What are cookies and why do we use cookies?

Cookies are small files that are stored on your hard drive. There are session cookies, which are deleted after you close your browser, and persistent cookies, which are stored on your device for a longer period.

We also differentiate between the purposes for which cookies are set.

- Strictly necessary cookies are essential for the proper functioning of the website and its applications. These cookies cannot be disabled in our systems. However, you can configure your browser to notify you about them or to block these cookies. Please note that some areas of the website may not function correctly as a result.
- With functional cookies, the website can provide enhanced functionality and personalization. They may be set by us or by third party providers whose services we have added to our pages. If you do not allow these cookies then some or all of these services may not function properly.

- Performance cookies allow us to count visits and traffic sources so we can measure and improve the performance of our site. They help us to know which pages are the most and least popular and see how visitors move around the site. If you do not allow these cookies we will not know when you have visited our site and will not be able to monitor its performance.
- Targeting cookies may be set through our site by third parties (e.g. advertising partners). They may be used by those companies to build a profile of your interests and show you relevant adverts on other sites. They do not store directly personal information but are based on uniquely identifying your browser and internet device.

Which cookies does this website use on which legal basis?

On your first visit to the website, we display a cookie dialog asking for your consent to set functional, performance and targeting cookies.

Strictly necessary cookies are set in accordance with Art. 6 para. 1 lit. b GDPR (performance of a contract) or Art. 6 para. 1 lit. f GDPR (legitimate interest), as these cookies are essential for the proper functioning of the website. Consent is not required for this.
